Dear Mr. Catanach:

McElvain Energy, Inc. (OGRID No. 22044) seeks administrative approval of an unorthodox well location for its **EK 30 BS2 Federal Com No. 1H Well** to be completed within the E-K; Bone Spring Pool (Pool Code 21650) underlying Section 30, Township 18 South, Range 34 East, N.M.P.M., Lea County, New Mexico. This well will be drilled from a surface location 175 feet from the South line and 860 feet from the East line (Unit P) of Section 30. The first perforation will be located 330 feet from South line and 854 feet from the East line (Unit P) and the last perforation will be 330 feet from the North line and 652 feet from the East line of Section 30 (Unit A). The E-K; Bone Spring Pool is governed by the Special Rules as adopted by Division Order R-4981. These Special Rules require 80-acre spacing units and further require that the completed interval for a well be located within 150 feet of the center of the quarter-quarter section. As a result, the completed interval for this proposed well will be unorthodox because it is closer than 510 feet from the northern, southern, and southwestern boundaries of the project area. It is also closer than 510 feet to the boundary of spacing unit in the W/2 SE/4 of Section 30. Approval of the unorthodox completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.

**Exhibit A** is the Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **EK 30 BS2 Federal Com No. 1H Well** encroaches on the spacing and proration units to the North, South, Southwest, and also the W/2 SE/4 of Section 30.

**Exhibit B** is a land plat for Section 30 and the surrounding sections that shows the proposed **EK 30 BS2 Federal Com No. 1H Well** in relation to adjoining units and existing wells.



**Exhibit C** is a list of the parties affected by the encroachment to the North, South, and Southwest, as well as those parties in the W/2 SE/4. Each of the parties listed on Exhibit C have been provided notice of this application by certified mail, and has been advised that if they have an objection it must be filed in writing with the Division within 20 days from the date the Division receives this application. In addition, a courtesy copy of this application has been provided to the BLM-Carlsbad Office.

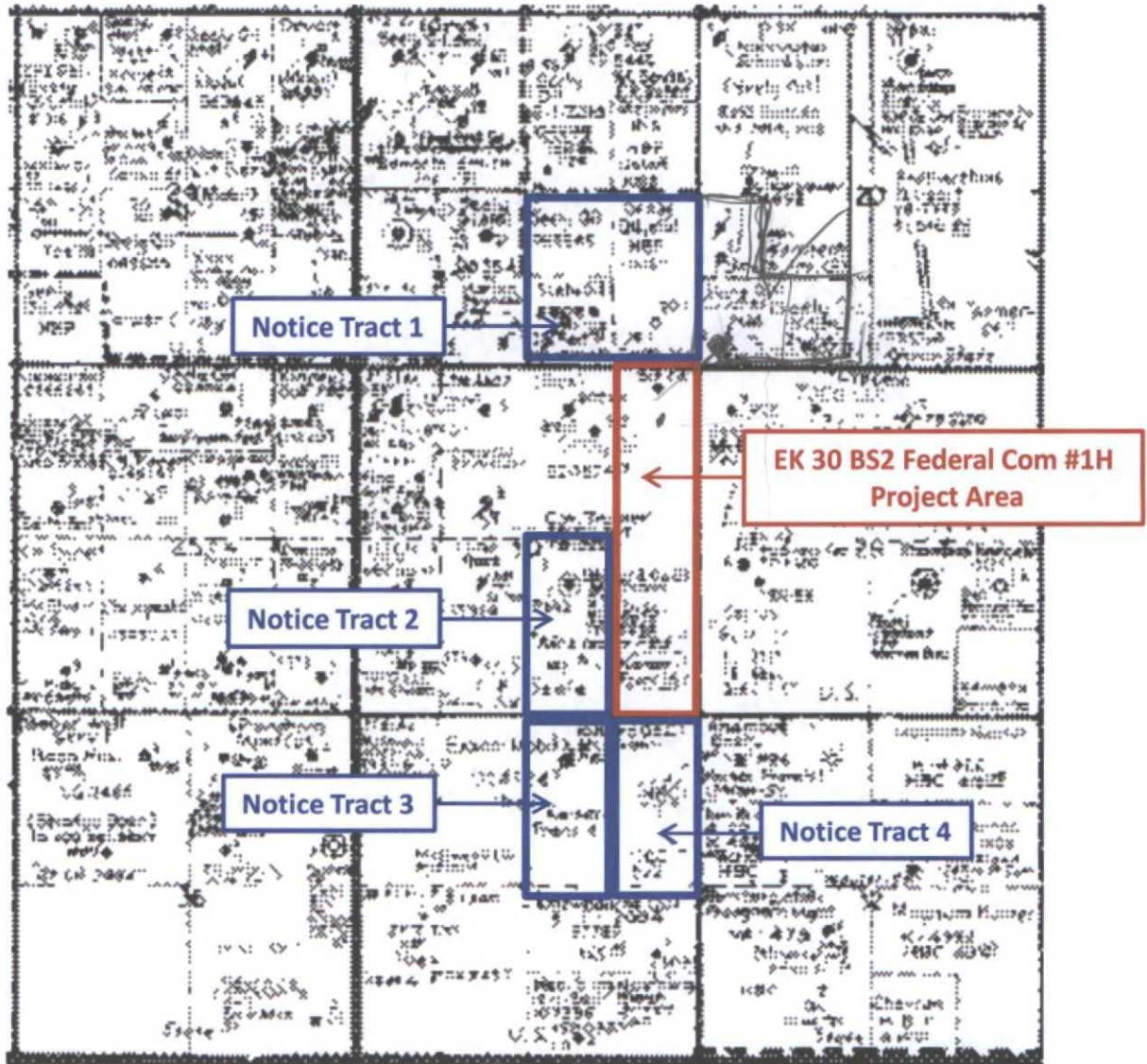


