Describe Cause of Problem and Remedial Action Taken.* When tanks were being filled with produced water for treatment, it was found that the valves were not retightened after new gaskets were installed, causing a 75 barrel spill inside of containment. Immediately retightened all valves and gaskets on the frac tanks to stop further leaking.		
Describe Area Affected and Cleanup Action Taken.* The entire spill occurred within containment. The liner was checked for holes and none were found. A vacuum truck was used to recover the entire spill and place back into another frac tank. No further action required.

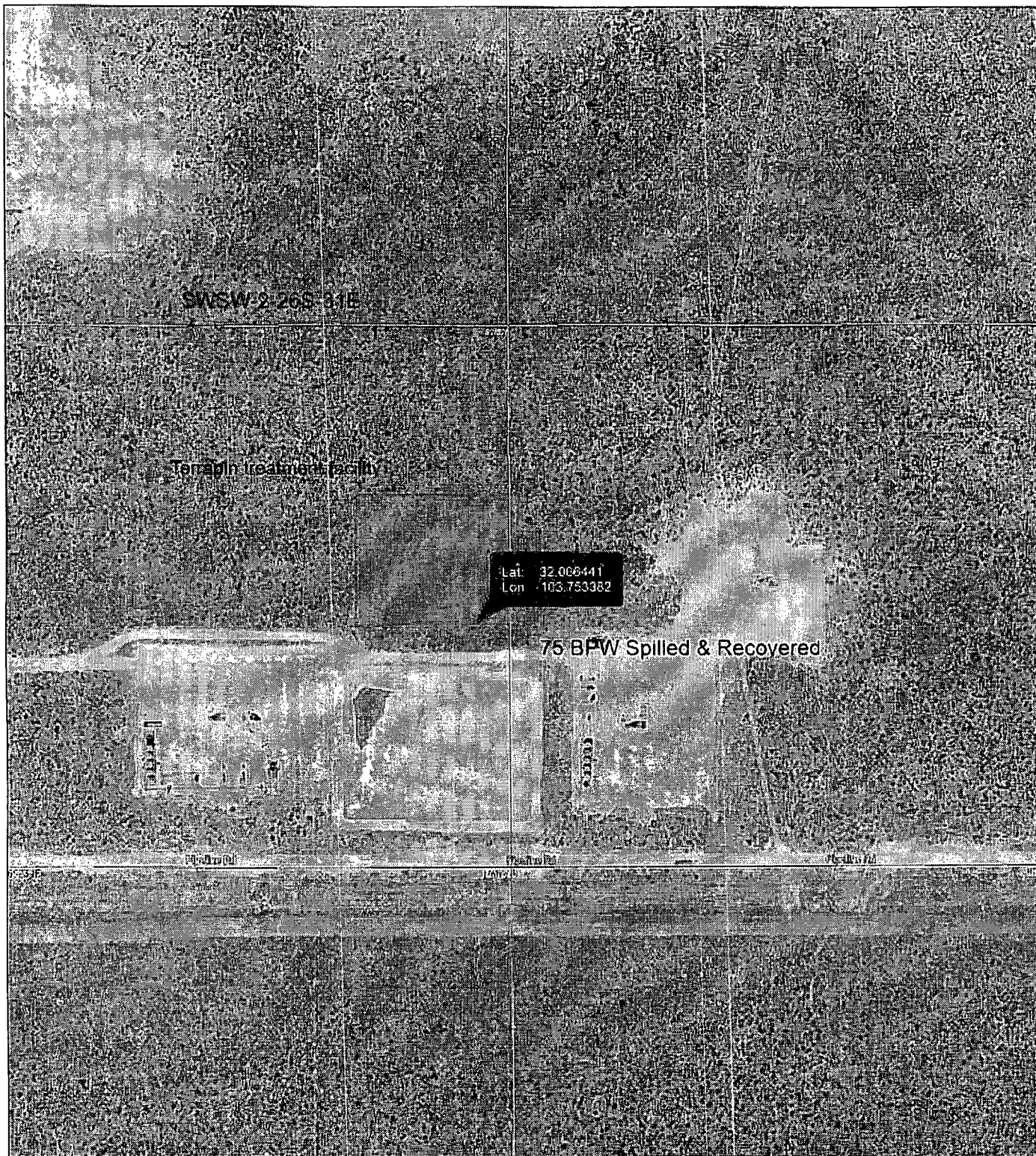
