Marbob Energy Corporation would request permission to directional drill the above described well to a bottom hole location of 1410' FSL and 700' FWL of Section 14, Township 26 South, Range 24 East.

This well was drilled to total depth vertically of 7820 feet. After logging, we believe that the best possibility of making a successful well in this proration unit could be done by kicking this well to a bottom hole location 1410' FSL and 700' FWL of Section 14.


Based on existing wellbore control, the current vertical penetration has narrowly missed a N/NE trending morrow sand channel. Allowing us to deviate the well to the W/SW should result in our hitting a pay sand. The economics behind this allowance will

essentially save our company approximately \$250,000 - the cost of drilling a new well.

This unorthodox location would be crowding the west offset lease. That lease is operated by Yates Petroleum Corporation. A copy of their waiver to this application is attached as Exhibit A. We have notified the Bureau of Land Management regarding this proposal. David Glass gave us verbal approval for this procedure subject to OCD approval. A copy of the original From C-102 is attached as Exhibit B. We are proposing to set plugs back up to a depth of 4500 feet subsurface and that would be our kick off point. We would then deviate the hole to a bottom hole location 1410' FSL and 700' FWL of Section 14. As soon as we receive information on the angle, penetration point, and lateral length, we will fax that information to you.
