

RE: Application for Administrative Approval of Unorthodox Location / Red Federal #4 *B*-015-30193 2310' FSL and 1575' FEL Section 17-17S-30E Eddy County, New Mexico

Dear Mr. Stogner:

Marbob Energy Corporation hereby makes Application pursuant to Oil Conservation Division Rule 104.F for Administrative approval to drill the above referenced Red Federal No. 4. Marbob Energy proposes to drill the Red Federal No. 4 to an approximate depth of 4800'. If successful, the proposed well would be completed in the Loco Hills Paddock Pool.

The orthodox location of 2310' FSL and 1650' FEL placed the well pad directly over a PNM Gas Services pipeline. A move to the west would have placed the well pad between the before mentioned PNM pipeline and a GPM natural gas pipeline. Marbob Energy preferred to move, to the east, the minimum distance needed to safely construct and drill the Red Federal No. 4. This move resulted in the unorthodox location of 2310' FSL and 1575' FEL. Therefore, requiring this Application for Administrative Approval of Unorthodox Location.

Attached to this application, please find a Form C-102 showing the footage and the proration unit of the proposed well. Also, attached are plats showing the offset interest owners of the producing interval (Exhibit A) and the layout of the proposed location (Exhibit B).






