On behalf of Patina San Juan, Incorporated and pursuant to Division Rule 104.F and the applicable rules governing the Blanco-Mesaverde Pool, we request administrative approval for an unorthodox well location for the Patina San Juan Jacquez 02 No. 04 Well at the surface and bottomhole locations reflected above.

The straight-hole well will be drilled to a depth sufficient to test the Mesaverde formation, Blanco Mesaverde pool (72319; Order No. R-10987-A, as amended.). The pool rules for the pool currently provide that wells shall be drilled no closer than 660' to the outer boundary of the 320-acre GPU and no closer than 10 feet to any quarter-quarter section line or subdivision inner boundary. Patina San Juan does not plan to produce from any shallower formations from the proposed wellbore.

Patina San Juan seeks an exception from the applicable well location rules in order to accommodate the current use of the surface for irrigated farmland agricultural operations. A standard

location was originally planned, but the owner of the surface, Mr. Pat Walters, maintains a side-roll irrigation sprinkler system on significant portions of the NW/4 of Section 2 and standard well locations in units C, D and E would materially interfere with the operation of the sprinkler system. Photographs of the NW/4 of Section 2 are enclosed. Further, Patina's engineering staff has determined that directional drilling from the unorthodox surface location to a standard bottom-hole location would add approximately \$130,000.00 in well costs, and under the circumstances, cannot be economically justified.

The W/2 of Section 2, T-31-N, R-13-W will be dedicated to the well and is the third Mesaverde infill well within the GPU. A plat showing the W/2 spacing unit, the proposed unorthodox surface and bottom hole locations, and adjoining spacing units and wells is attached as Exhibit "A". A list of affected parties in the adjoining S/2 of Sections 34 and W/2 of Section 35, T32N, R13W and in the E/2 of Section 3, T31N, R13W to whom notice and waiver requests are being sent is attached as Exhibit "B". Patina San Juan is the operator of the referenced adjoining units in Sections 35 T32N, R13W, and Section 3 T31N, R13W. Patina owns 100% of the working interest in the E/2 of Section 3 and the W/2 of Section 2. The non-operating working interest owners in Section 35 are being notified. In the S/2 of Section 34, T32N, R13W, San Juan Resources of Colorado is the operator of the Mesaverde unit and HEC/Pure Resources operates the Basin-Fruitland Coal Gas unit. Both of those operators are also being notified.
