COMMINGLING ORDER PLC-274

XTO Energy Inc.

The above-named company is hereby authorized to surface commingle gas production from the Basin-Dakota (Prorated Gas - 71599), Basin-Fruitland Coal (Gas - 71629), Wildcat Basin-Mancos (Gas - 97232), Fulcher Kutz-Pictured Cliffs (Gas - 77200) and Kutz-Gallup (Oil - 36550) Pools within the following-described area that is comprised of Federal Leases No. NMSF-077384 and NMSF-078019, San Juan County, New Mexico:

Commingled Area

Sections 35 and 36, Township 28 North, Range 11 West, NMPM;
Sections 1 and 12, Township 27 North, Range 11 West, NMPM;
E/2 of Section 6, Township 27 North, Range 10 West, NMPM;

Within the commingled area, there are currently forty-three (43) wells operated by XTO Energy, Inc. that produce from one or more of the subject oil and gas pools. These wells are shown on Exhibit "A" attached to this order.

Each of the subject wells shall be equipped with an allocation meter that will continuously meter production prior to commingling. Gas production from each of the subject wells shall be determined by ratio utilizing allocation meter volumes and sales meter volumes. Compressor fuel usage shall be allocated based upon each well's production. The total production from all wells shall be metered by a gas sales meter located at the Pipkin Compressor Site in the SE/4 NW/4 of Section 36, Township 28 North, Range 11 West, NMPM. Liquids shall not be commingled.



Future wells that are located within the commingled area that produce from one or more of the subject pools may be added to this commingling authority without additional notice by filing a letter with the Santa Fe Office of the Division, and by filing any additional forms that may be required by the Bureau of Land Management.

Future wells that are located outside the commingled area that produce from the subject pools, or from any additional pools may be added to this commingling authority by formal amendment of this order. Such amendment shall include additional notice to all interest owners within the commingled

area, and to each interest owner owning an interest in the acreage to be added.

It is the responsibility of the producer to notify the transporter of this commingling authority. The operator shall notify the Aztec district office of the Division upon commencement of commingling operations.
