All located in San Juan County, New Mexico.


Gas production shall be allocated to each lease by separately metering the production from each well prior to commingling. Oil production will not be commingled.

It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: The commingled natural gas production shall be delivered to a sales meter at the Ohio "E" Government Well No. 18-1 located in the NW/4 NE/4 of Section 18, Township 31 North, Range 12 West, NMPM, San Juan County, New Mexico.

The operator shall notify the Aztec district office of the Division prior to implementation of the commingling operations.
