BP America Production Company request permission to surface commingle production the Blanco Mesaverde, Blanco Pictured Cliffs and Basin Fruitland Coal Pools from our Neil A 8R & 24 and Neil LS 16. Surface commingling Blanco Mesaverde production will consist of well Neil A No. 8R, API No. 30-045-27001, Blanco Pictured Cliffs production will be from Neil LS 16 API 30-045-23173 and Basin Fruitland Coal production will be from Neil A 24. The production from each well will be metered prior to commingling then the commingled production will flow into through the separator where the liquids will be removed. The commingled gas will then be sent through compression prior to entering the sales meter. Please reference the attached schematics reflecting the Proposed Surface Commingling Layout provided for your reference.

The working interest, royalty and overriding royalty interest owners in the subject wells are identical. The proposed commingling of production is to reduce operating expenses between the wells and will result in increased economic life of the wells.

BLM has also been notified of this proposal by copy of BLM Form 3160-5.
