Dear Mr. Roe:

Reference is made to the following:

- (i) your original application (administrative application reference No. pTDS0603035146) submitted to the New Mexico Oil Conservation Division ("Division") on January 20, 2006; and
- (ii) the Division's records in Santa Fe and Aztec: all concerning Dugan Production Corporation's request for an unorthodox oil well location in the Bisti-Lower Gallup Pool (Oil **5890**) for its Bitsili Well No. 1 that was drilled 1470 feet from the North line and 1780 feet from the East line (Unit G) of Section 19, Township 24 North, Range 9 West, NMPM, San Juan County, New Mexico.

## **The Division Director Finds That:**

- (1) The subject application has been duly filed under the provisions of Division Rules 104.F;
- (2) the Bisti-Lower Gallup Pool is currently governed by Order No. R-1069-G, which provides for 80-acre oil spacing and proration unit, and requires that wells be located no closer than 330 feet to any quarter-quarter section boundary of the proration unit;
- (3) the Bitsili Well No. 1 was originally drilled at standard oil well location to test the Dakota formation;
  - (4) the Dakota formation was found to be poorly developed with marginal oil production;
- (5) Dugan Production Corporation now proposes to complete the Bisti-Lower Gallup oil Pool and down hole commingle production from the Dakota and the Gallup Pools;

- the Bitsili Well No.1 is at an unorthodox oil well location with respect to the Bisti-Lower Gallup oil Pool pursuant to Division Order No. 1069-G;
- Dugan Production is the only lease holder and operator within one-half mile radius of the Bitsili Well No.1, therefore, there are no offset operators that require notice; and
- It appearing that the applicant has satisfied all of the appropriate requirements of Rule 104.F, the subject application should be approved.

## It Is Therefore Ordered That:

- By the authority granted me under the provisions of Division Rule 104.F (2), the (1) above-described unorthodox Bisti-Lower Gallup oil well location for Dugan Production Corporation's Bitsili Well No. 1 is hereby approved.
- Jurisdiction of this case is retained for the entry of such further orders as the Division (2) may deem necessary.
