- B.) A plat showing the proposed unorthodox location, the respective proration units, and the offsetting proration units (Exhibit B).



The acreage dedicated to this well is 80 acres, E/2 NE/4 Sec. 31 T16S R33E. Mack Energy Corp. also operates the acreage that we are encroaching upon and therefore no offset operators need be notified. There are no other wells in this QQ producing from the Wolfcamp formation
