ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on February 2, 2006, at Santa Fe, New Mexico, before Examiner William V. Jones.

NOW, on this 13th day of February, 2006, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.
- There is need for the extension of the vertical limits of the Nash Draw-Delaware Pool (Pool Code 47545) in Eddy County, New Mexico to include the top of the Lamar of the Delaware Mountain Group and continue down to the base of the Avalon sands in the Upper Bone Spring formation as defined in Type Log Bass Enterprises Production Company Poker Lake Unit Well No. 192 (API No. 30-015-33362) located in Unit L of Section 8, Township 24 South, Range 30 East, NMPM. The measured vertical depth to the base of the Avalon sands is 7438 feet below ground level. There is also need for the redesignation of the pool as the Nash Draw-Delaware/Bone Spring (Avalon Sand) Pool.
- (3) There is need for the creation of a new pool in Eddy County, New Mexico for the production of oil from the Bone Spring formation, bearing the designation of Paduca-Bone Spring Pool (Pool Code 96641). The Paduca-Bone Spring Pool was

discovered by the Devon Oil Company Cotton Draw Unit Well No. 81 (API No. 30-015-29345) located in Unit L of Section 2, Township 25 South, Range 31 East. NMPM, which was completed in the Bone Spring formation on February 17, 2005. The top of the perforations is at 8,725 feet.

(4) There is need for extensions to the East Burton Flat-Strawn Gas Pool, the Cedar Lake-Atoka Pool, the Northeast Collins Ranch-Wolfcamp Gas Pool, the West Cottonwood Creek-Wolfcamp Gas Pool, the Crozier Bluff-Atoka Gas Pool, the North Illinois Camp-Morrow Gas Pool, the Otis-Atoka Gas Pool, the Pecos River-Morrow Gas Pool, and the Wye-Delaware Pool, all in Eddy County, New Mexico.

- (a) The vertical limits of the Nash Draw-Delaware Pool (Pool Code 47545) in Eddy County, New Mexico are hereby extended to include the top of the Lamar of the Delaware Mountain Group and continue down to the base of the Avalon sands in the Upper Bone Spring formation as in Type Log Bass Enterprises Production Company Poker Lake Unit Well No. 192 (API No. 30-015-33362) located in Unit L of Section 8, Township 24 South, Range 30 East, NMPM. The measured vertical depth to the base of the Avalon sands is 7438 feet below ground level. The Nash Draw-Delaware Pool is hereby redesignated the Nash Draw-Delaware/Bone Spring (Avalon Sand) Pool.
- (b) A new pool in Eddy County, New Mexico classified as an oil pool for Bone Spring production is hereby created and designated as the Paduca-Bone Spring Pool (Pool Code 96641), consisting of the following described area:

Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.
- (2) The effective date of this order and all creations, redesignations, and extensions of vertical and horizontal limits included herein shall be March 1, 2006.

NOW, on this 25th day of January, 2006, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.
- (2) There is need for the creation of a new pool in Eddy County, New Mexico for the production of oil from the Bone Spring formation, bearing the designation of Cottonwood Draw-Bone Spring Pool (Pool Code 97494). The Cottonwood Draw-Bone Spring Pool was discovered by the Latigo Petroleum, Inc. Marine "19" Federal Well No. 1 (API No. 30-015-33981) located in Lot 2 of Section 19, Township 25 South, Range 27 East, NMPM, which was completed in the Bone Spring formation on October 23, 2005. The top of the perforations is at 7,706 feet.
