Dear Mr. Stogner,

Marathon Oil Company requests administrative approval to drill the Mark Owen #14 well as a Grayburg producer at an unorthodox location as an exception to Rule 19.15.3.104.B.(1). The proposed Mark Owen #14 well location is 1090' FSL & 760' FWL of Section 35, Township 21 South, Range 37 East, Lea County. The unorthodox location is requested because numerous active pipelines (owned by different operators and transporters) are situated in the area where a legal location would occur. In order to avoid encroaching upon these pipelines and causing a potential safety hazard, the well location was placed in an area of avoidance in the 40 acre drilling unit of the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 35, T21S, R37E.

At the requested location, the proposed well is 230' from the $\frac{1}{4}$ $\frac{1}{4}$ Section Line to the North. Marathon Oil Company is the operator of the lease on which the well has been staked and is also the operator of the lease North of the $\frac{1}{4}$ $\frac{1}{4}$ Section Line. Because of this, no other operator or lease holder is being encroached upon with this well placement. Thus no operators are being notified and no waivers are included with this request and submittal.



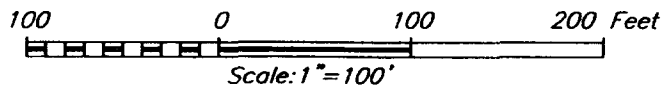

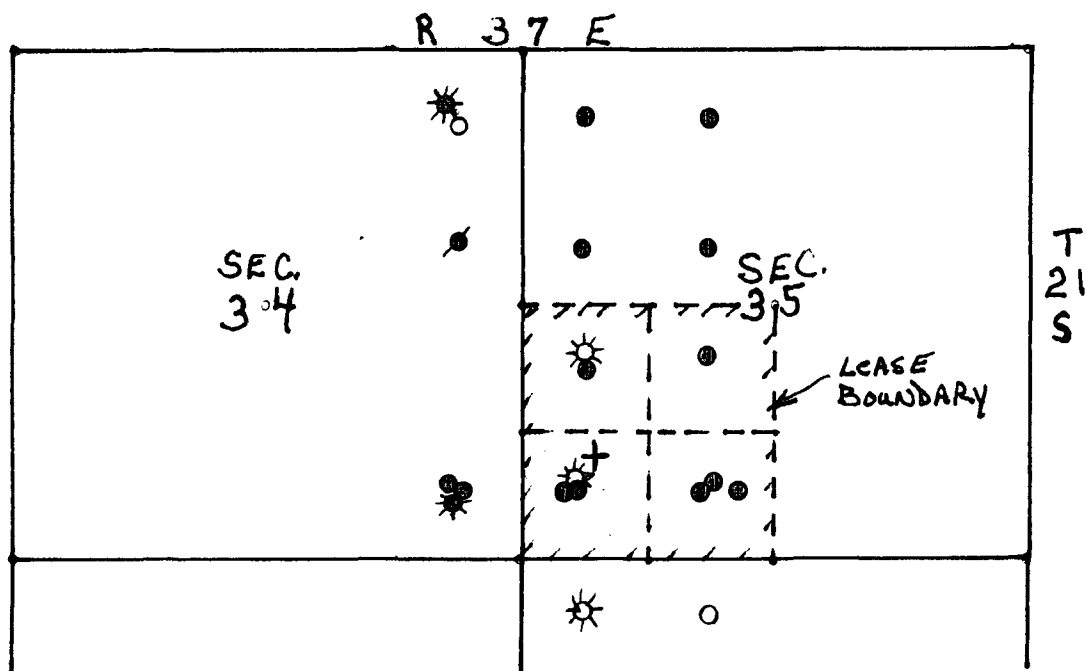
