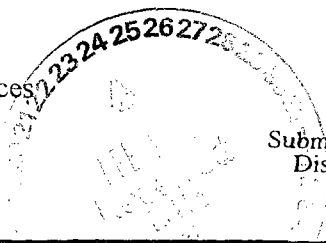

Describe Cause of Problem and Remedial Action Taken.* A hole in the 6" injection line between LJ #49 and the highway caused less than 50 bbls to leak out. A saddle was welded over the hole and the hole was sealed. The injection line was back in use by 4:00pm, 2/16/06.

Describe Area Affected and Cleanup Action Taken.* The affected area is barren rocky pasture land in the right-of-way. The leaking produced water went down the right-of-way and the fence line to the south 150' by 5' at the widest point.
