Pipeline pilot reported release at Big Sinks 2-24-30 #3H. Release was on PW poly line from charge pump at btry to feed jet pump.

The spill was a result of power not being switched OFF to charge pump when pumper reported tbg leak on well.

Charge pump has been switched OFF and valves on poly line isolated. Vac truck is in route and contract gang will repair poly line.
