
Describe Cause of Problem and Remedial Action Taken.*

On October 1, 2015 6:34 PM at the Ross Ranch 10 Fed 1 SWD a 3" threaded nipple corroded on the gun barrel and caused a release of 400bbl produced water into lined containment. The Lease Operator immediately shut in the wells going to the SWD and did a lock out tag out on the gun barrel until repairs could be made.

Describe Area Affected and Cleanup Action Taken.*

All 400bbl of fluid released were contained in lined containment and a vac truck was called to clean up containment. All 400bbls produced water were recovered and the containment was checked for holes with none found.
