Describe Cause of Problem and Remedial Action Taken.*

The 3-phase separator lost gas psi causing it not to dump properly which over pressured a 30# gauge that broke and released approximately 8bbl produced water and 2bbl oil out the gauge. The well was immediately shut in and a dike was built to stop the fluid from running off location.

Describe Area Affected and Cleanup Action Taken.*

Approximately 8bbl of mixed fluid stayed inside containment and approximately 2bbl mixed fluid went into pasture due to a hole in the containment. A vac truck was contacted to start recovering fluid and 7bbl mixed fluid was recovered. An environmental agency will be contacted for the clean-up.
