Describe Cause of Problem and Remedial Action Taken.*

Human error caused a truck to overfill onto COG's SRO St. Com #043H location. Approximately 9bbls of oil were released. Gibson Energy contacted Talon/LPE to conduct an emergency response and to recover the standing fluids. A vacuum truck was utilized to recover the standing fluids. Approximately 5bbls of oil were recovered.

Describe Area Affected and Cleanup Action Taken.*

The impacted area was near the LACT unit at the tank battery. All of the fluid was contained to the location. After recovering the standing fluids Talon/LPE covered the impacted area with an organic sorbent to further stabilize the surface of the impacted area should a precipitation event occur before remediation activities are complete. The impacted area will be excavated, confirmation soil samples will be obtained, analyzed for TPH, BTEX, and Chloride, and the analytical results will be submitted to NMOCD for review prior to backfill.
