This release was caused when a poly flowline was hit by a vehicle and damaged. The line was shut in and vacuum trucks were dispatched but were unable to recover any fluid.

Describe Area Affected and Cleanup Action Taken.\*

The release is located in the pasture approximately 0.75 miles to the northeast of the well pad. The area of impact is approximately 225' x 150'. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
