
Describe Cause of Problem and Remedial Action Taken.*

The battery lost power from work being conducted by Xcel Energy and the pumps/equipment at the battery not to run and the tanks overflowed. Vacuum truck(s) were called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 100'X 20' within the lined/hard sided containment of the battery. All of the produced water was recovered using a vacuum truck (s). Power was restored to the battery. Depth to Ground Water: >100' (approximately 300', per Chevron/Texaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on the battery being lined/hard side containment and all released crude oil recovered, Yates Petroleum Corporation requests closure.

Cause of the release was from Excel Energy conducting work in the area that resulted in Excel shutting off electrical power to the SWD that caused tanks to overflow, Yates was not notifying so measures could be taken to prevent the tanks from overflowing. **All released produced water was contained within the lined/bermed battery.** Vacuum truck(s) were called, electrical power was restored. A Form C-141 with complete information will be submitted.
