
Describe Cause of Problem and Remedial Action Taken.\*

The release was caused when a water hauler (M&R trucking) left the load out valve open, causing the water to leak out onto location. The release stayed within the confines of the locations pad.

Describe Area Affected and Cleanup Action Taken.\*

150ft long by 75ft wide between the batteries loadout area and the pump jack. Concho will have the spill site sampled to delineate any possible contamination from the release and will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
