
Describe Cause of Problem and Remedial Action Taken.*

On July 15, 2015 at 10:30 PM severe lightning struck the tank at the Todd 15 G Fed 7 causing the battery to catch on fire. This caused the tank to explode and 150 bbl of produced water and oil was released into containment. All the fluid stayed in containment, but this was an earth containment and has holes in it. All 150 bbls of produced water and oil were recovered by PSI after it cooled down.

Describe Area Affected and Cleanup Action Taken.*

The 150 bbls of produced water and oil that was leaked into the containment were all recovered. This is an earth containment and has holes. Day crew will assess for further cleanup.
