Describe Cause of Problem and Remedial Action Taken.* A union on the tank eroded away, causing the pump to fail and shut down. As a result 250 bbls of produced fluid was released and captured inside the fire wall. A vacuum truck was able to recover approximately 210 bbls.

Describe Area Affected and Cleanup Action Taken.* SSSI delineated the affected area as detailed in a copy of their report dated 02/19/11 (an original of the report has been provided to the Artesia NMOC D Dist. Office). The affected area was remediated as discussed in Section V. of the report. As noted in the report additional remediation will be necessary when the facility is inactive.
