A line located near the wellhead at WIW well developed a pinhole size leak, the line was immediately shut-in, and the line was repaired. A vacuum truck was immediately brought to the facility, standing fluids were recovered.


Describe Area Affected and Cleanup Action Taken.*

The affected area is located on location and in farm land south of the WIW well. This area was measured to be 10'-30' W x 175' L. R.T. Hicks Consultants has been contracted for the corrective actions on release. Work Plan: The impacted material from the release will be excavated and transported to and NMOCD approved Land Fill for disposal. Conformation soil samples will be collected upon completion of excavation. Like material will be utilized to backfill the excavated area.

Site Ranking: Depth to ground water <50', Wellhead protection Area>1000', Distance to Surface Water Body>1000'. Total Ranking score: 20.
