The packing blew out of the stuffing box causing a spill of 2 bbls of oil and 3 bbls of produced water. A vacuum truck recovered 2 bbls of fluids and the packing was replaced.

Describe Area Affected and Cleanup Action Taken.*
The affected area is approximately 250' x 25' on location near the well head with a small overspray area just west of location. Remediation will be completed in accordance with a remediation plan approved by both NMOCD and the BLM.

This is to inform you that Oxy Permian had a leak at the Nimitz 12 Federal #3H on April 22, 2016. Oxy spilled 2 bbls of oil and 3 bbls of produced water due the stuffing box packing blowing out. The preliminary report shows the leak measuring approximately 10' x 60' on location near the well head. Recovery is in progress. The release is located in U/L B of Section 12, T24S, R30E of Eddy County, NM. BBC International will remediate the location at a later date and an initial C-141 will follow. Driving directions: From Carlsbad on US285, turn left on NM31 and go 7 miles, turn right on NM128 and go east to Twin Wells Rd, turn south and go 6 miles, turn right and go west on dirt road 1 mile, turn left and go 100 yards to location.
