Dear Mr. Catanach:

Matador Production Company (OGRID No. 228937) filed an administrative application on February 22, 2016 for the administrative approval of an unorthodox well location for its Guitar 10-24S-28E RB #222H well (API No. 30-015-43693) to be completed within the Culebra Bluff; Wolfcamp, South Gas Pool (Pool Code 75750) underlying the N/2 of Section 10, Township 24S, Range, 28E, Eddy County, New Mexico. Attached as **Exhibit A** is a revised C-102 for the well.

As we have previously discussed, this application received a protest from Randy Cate, on behalf of RSC Resources, L.P., Cogent Energy, Inc., and Guardian Operating Corp. Matador reached an agreement with Mr. Cate in which he would withdraw his protest in exchange for Matador amending the NSL application to 990 feet off the midsection line of the N/2 of Section 10, Township 24S, Range, 28E, Eddy County, New Mexico. This letter reflects this change. All parties entitled to notice pursuant to the new C-102 already received notice of the NSL in February.

The revised perforations for the well based on the agreement with Mr. Cate are as follows:

Guitar 10-24S-28E RB #222H

- **Surface Hole Location:** 1753 feet from the North line and 205 feet from the East line of Section 10, Township 24 South, Range 28 East;
- **First Perforation Point:** 1635 feet from the North line and 330 feet from the East line of Section 10, Township 24 South, Range 28 East;
- **Last Perforation Point:** 1649 feet from the North line and 330 feet from the West line of Section 10, Township 24 South, Range 28 East; and
- **Bottom Hole Location:** 1649 feet from the North line and 240 feet from the West line of Section 10 Township 24 South, Range 28 East.

As you can see the proposed perforations will no longer encroach towards the interests located in the S/2 of Section 10. There are no special pool rules for this pool, and thus the setback requirements under Rule 19.15.15.10(B) of 660' apply. The completed interval for this well will be closer than 660' from the east and west boundaries of the project area, and notice was properly provided to affected parties in the adjoining spacing units in February. Matador Production Company requested this NSL in order to efficiently produce its interests in Section 10. This well is producing from the Culebra Bluff; Wolfcamp, South Gas Pool (Pool Code 75750).

Hi Leonard,

Zoe had mentioned that you had called on Friday concerning the Guitar 222 NSL application. After Randy Cate filed his protests, Matador negotiated directly with him and the parties agreed to amend the C-102 accordingly. In doing so, they decided to move the well to be 990' from the section half line – instead of 330' from the half line. This agreement is shown below in the email sent by Randy Cate to you and Will on March 22, 2016. This makes the location of the non-standard perforations a little more standard and they will only be encroaching now to the east and the west. All of the applicable offsets were notified about the east and west encroachments when the NSL was filed, and Mr. Cate was the only person who had protested. Since Mr. Cate's objections have now been satisfied, this application should be ready to be approved.
