
Describe Cause of Problem and Remedial Action Taken.*

A hole developed in the bottom of an oil tank. The tank has been removed and is in the process of being repaired.

Describe Area Affected and Cleanup Action Taken.*

Initially roughly 200bbls of oil were released from the tank and we were able to recover 18bbls with a vacuum truck. The spill area will be scraped to remove surface contamination. BBC will sample the spill site area to identify any possible contamination from the release. We will notify the OCD prior to any significant remediation work.
