Pursuant to Division Rule 19.15.15.13, COG Production LLC (COG) respectfully requests administrative approval of an unorthodox oil well location for its <u>Diamondback 22 State Com #11H</u> well. This well does not meet the 330' from the outer boundary of the producing area requirement. Due to limited surface locations, this well was drilled from a surface hole located 1365' from the east line of Section of 22 with the intent of producing only from the E/2E/2 of Section 22. Due to a miscalculation, the first perf is closer than 330' to the quarter quarter section line.

The affected offset tract is the W/2E/2 of Section 22, T26S, R28E.
