Dear Mr. Lowe:

Pursuant to Division Rule 19.15.15.13, COG Production LLC (COG) respectfully requests administrative approval of an unorthodox oil well location for its Diamondback 22 State Com #11H well. This well does not meet the 330' from the outer boundary of the producing area requirement. Due to limited surface locations, this well was drilled from a surface hole located 1365' from the east line of Section of 22 with the intent of producing only from the E/2E/2 of Section 22. Due to a miscalculation, the first perf is closer than 330' to the quarter quarter section line.

The affected offset tract is the W/2E/2 of Section 22, T26S, R28E. COG Production LLC is the designated operator of all of Section 22, T26S, R28E, however the ownership of the producing tract and the affected offset tract is not uniform. All owners in the offset tract are being notified by certified mail.

Attached is a Form C-102 showing the project area and the producing area of this well.

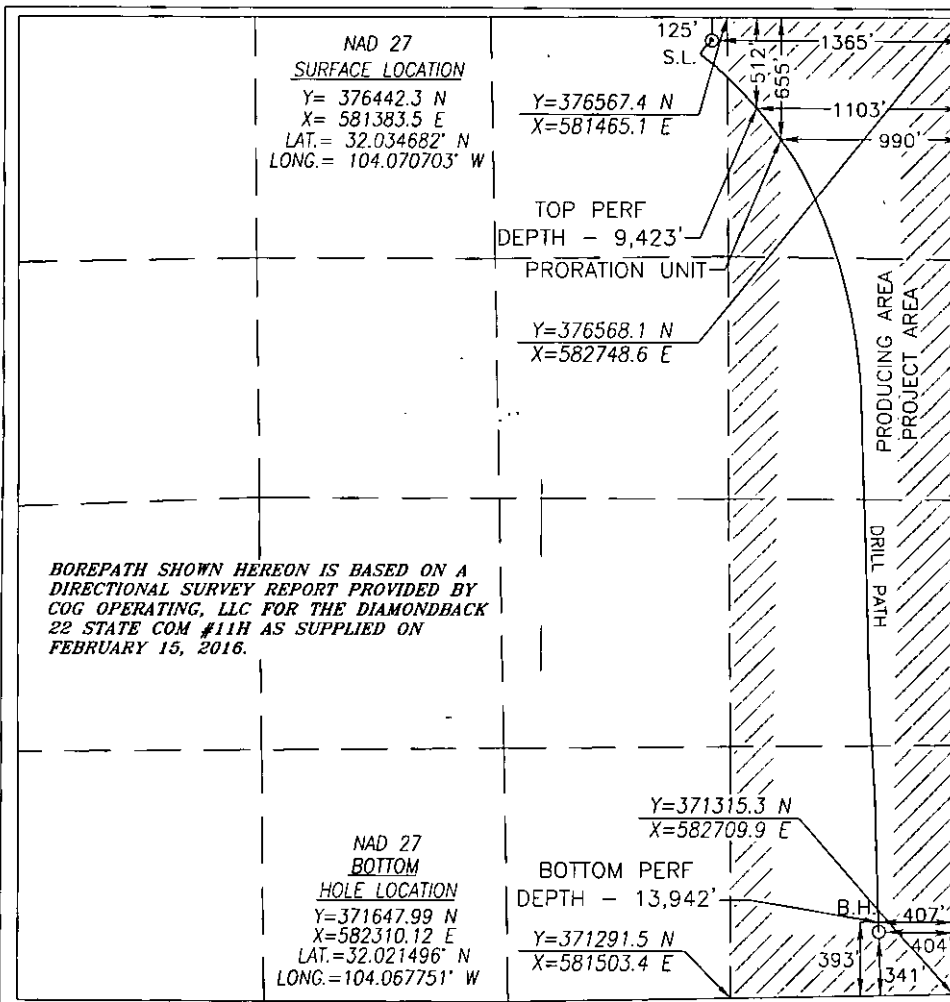


