This release was caused by a gasket failure on a separator. Vacuum trucks were dispatched to recover all standing fluid and Microblaze was applied to the impacted pasture area. The equipment was also pressure washed.

Describe Area Affected and Cleanup Action Taken.*

The majority of this release was contained within the lined bermed area; however a spray of fluid impacted the pasture area. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
