Buddy,

Yates has requested an extension with the BLM on restoration/reseeding work at the above location until July 1, 2011. This is in conjunction to a release that occurred on 8/11/2009, impacted soils were excavated and sample results are below RRAL's for the site ranking of zero (depth to ground water is zero). A Final C-141 and supporting documents were submitted on April 13, 2010. With the BLM's request to have this site restored/reseeded this summer, if there are no objections, Yates will begin work on June 15, 2011 which includes backfilling with clean soils to create a 3' cap of the excavation area and reseed with a BLM #2 seed mixture. Yates plans to have this project to be completed on or before by July 1, 2011 to take advantage of future monsoonal rains.
