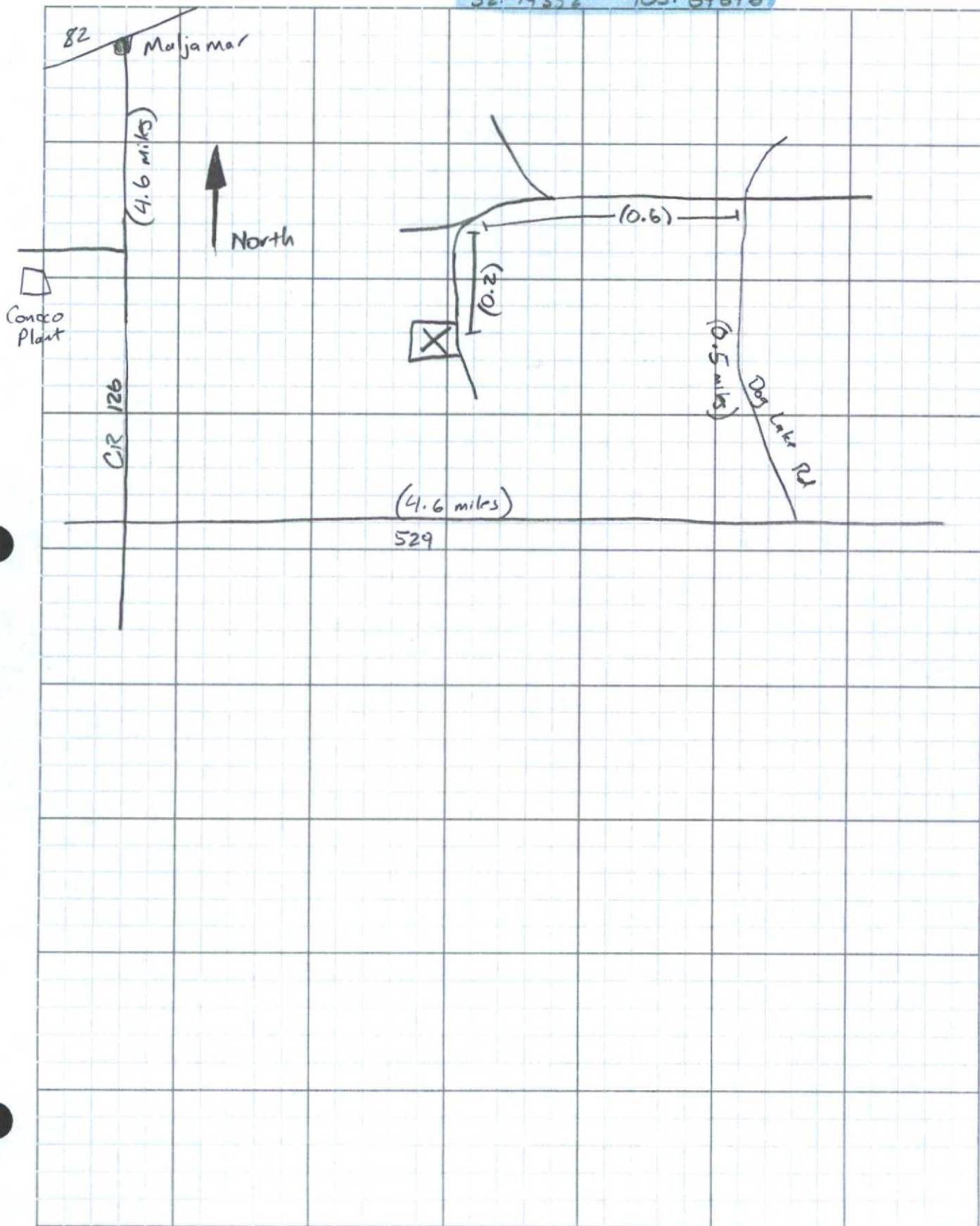

Good morning everyone

Today's daily report will be short w/no attachments. I'm working on a couple of spread sheets which will identify the sites that we are working on which will have the field cl- results and any extensions (laterally) that may be required as we delineate the side walls. For the moment today Doc and I work in the area L and K and started on the w. wall of the finger that heads N. to area J, the spreadsheets will clarify this. Area L has finally cleaned up at 30' S. of the original excavation, this sample from this wall will be sent to the lab for confirmation. Tomorrow Doc will continue to delineate laterally in area L, the new walls that have been formed with the excavation. The trackhoe and off road truck will continue to load and haul material to stockpile, while I and the backhoe will start delineating the N. side of the leak wall on the N. side of the fence. This will help in determining if the walls will have to be extended out any additional footage.

Raymie with EOG did come by the site today and discussed the auger rubbing, Cody with MMX discussed the site with Raymie and I will be getting with Cody to see if any action will be taken on EOG's part.
