A gun barrel surge caused 10 bbls of oil to leak inside the lined containment on location. A vacuum truck recovered all free-standing fluid.

Describe Area Affected and Cleanup Action Taken.*

The affected area is approximately 80' x 4' inside the lined containment on location. Remediation was completed by removing the contaminated material and replacing it with clean material.
