The gas production from each well shall be separately metered before commingling with production from other wells. The oil production from each well shall be measured with a combination of metering and well testing. The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C(2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules and Regulations.

This approval is subject to like approval from the New Mexico State Land Office before commencement of the commingling operations.
