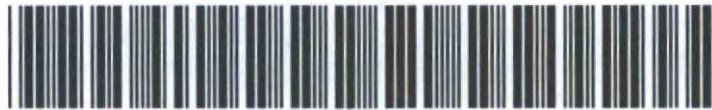



Purchased power to the facility went down several times and backup power failed to engage, causing station ESD system to activate multiple times. During one of the outages, the suction ESD valve failed to close all the way. Valve immediately up stream of the ESD was manually closed. I & E is troubleshooting to determine if future recurrence can be mitigated. A total of 44,988 MCF natural gas was vented to atmosphere.

Describe Area Affected and Cleanup Action Taken.*

No clean-up required for natural gas releases vented to atmosphere.





