The affected area is approximately 150' x 75' both on and off location. Remediation will be completed in accordance with a remediation plan approved by NMOCD.

This is to inform you that Oxy Permian had a release at the Rogers #006 on August 28, 2016. Oxy released 20 bbls of oil due to the stuffing box packing blowing out of the well head. The preliminary report indicates the leak measures 20' x 120' both on and off location. A vacuum truck recovered 19 bbls. The release is located in U/L J of Section 23, T18S, R26E in Eddy County, NM. Driving directions: From Carlsbad, go South on US285 to Dayton Rd, turn East and go 1 mile to stop sign, continue and take left at "Y", go 0.2 mile to location.
