Here are the answers to your questions below:

1. The surface equipment for the Spruce Goose Federal #2H & #3H is located at the #3H battery and is separate from any other wells.
2. The N/2N/2 & S/2N/2 of Section 7 are in the process of being communitized, therefore, the Spruce Goose Federal Com #2H & #3H will be reported under the same CA number. As I understand it, this would mean that there would be no surface commingling application required.
3. The gas from the Spruce Goose Federal #2H & #3H is being transported by flowline from the Spruce Goose Federal #3H battery to a DCP sales meter that is located **AT** the Piper Federal #1H Battery, but is completely separate from any production other than the Spruce Goose Federal #2H & #3H wells.
