EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its **Convoy 28 State Com No. 501H Well** to be completed within the Triste Draw; Bone Spring, East Pool (Pool Code 96682) underlying Sections 28 and 33, Township 24 South, Range 33 East, N.M.P.M., Lea County, New Mexico. This well will be drilled from a surface location 598 feet from the North line and 1,275 feet from the East line (Unit A) of Section 28. The upper most perforation will be located 330 feet from North line and 1,275 feet from the East line (Unit A) of Section 28 and the lower most perforation will be 330 feet from the South line and 1,275 feet from the East line (Unit P) of Section 33. Since this acreage is governed by the Division's statewide rules which provides for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it is closer than 330 feet to the northwestern, western, and southwestern boundaries of the project area.

The proposed **Convoy 28 State Com No. 501H Well** is an infill well developing the E/2 E/2 of Sections 28 and 33. EOG-Y Resources Inc. ("EOG-Y"), formerly known as Yates Petroleum Corporation, is a wholly-owned subsidiary of EOG, is the Division-designated operator of four existing one-mile wells in the E/2 of Section 28 and the E/2 of Section 33. The E/2 of Section 28 is comprised of State Lease No. VB-1743, which has identical ownership. EOG-Y is the Division-designated operator of the Convoy BUC State No. 1H in the E/2 E/2 of Section 28 and the Convoy BUC State No. 2H in the W/2 E/2 of Section 28. The E/2 of Section 33 is comprised of State Lease VO-7378, which also has identical ownership. EOG-Y is the Division-designated

operator of the Caravan State BVX 11H in the E/2 E/2 of Section 33 and the Caravan State BVX No. 10H in the W/2 E/2 of Section 33.

The working interest owners in the W/2 E/2 of Section 28 are being invited to participate in the **Convoy 28 State Com No. 501H Well**. The working interest owners in the W/2 E/2 of Section 33 will also be invited to participate in the **Convoy 28 State Com No. 501H Well**. Thus, all working interest owners in the affected tracts to the West are invited to participate in the proposed **Convoy 28 State Com No. 501H Well**. Nonetheless, the working interest owners in the affected tracts to the West have been provided notice of this hearing. Approval of the unorthodox completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.

Exhibit A is a C-102 for the **Convoy 28 State Com No. 501H Well** which shows that the completed interval encroaches on the spacing and proration units to the Northwest, West, and Southwest.

Exhibit B is a land plat for Sections 28 and 33 and the surrounding sections that shows the **Convoy 28 State Com No. 501H Well** in relation to adjoining units and existing wells.
