Dear Mr. Catanach:

EOG Resources, Inc. (OGRID No. 7377) previously permitted the **Neptune 10 State Com No. 503H** as a horizontal well within a 320-acre project area in the ~~Triple X; Bone Spring Pool~~ (59900) comprised of the E/2 W/2 of Section 3 and the E/2 W/2 of Section 10. The Division issued Administrative Order NSL-7483 authorizing a first perforation 330 feet from the South line, 2,480 feet from the West line (Unit N) of Section 10 with a final perforation 330 feet from the North line, 2,480 feet from the West line (Lot 3) of Section 3.

EOG commenced drilling the well from a surface location 330 feet from the South line and 2,308 feet from the West line of Section 10 (Unit N). However, in drilling the well, EOG deviated slightly from its planned well path. The first perforation will occur at 434 feet from the South line, 2,486 feet from the West line (Unit N) of Section 10 and the final perforation will occur at 437 feet from the North line and 2,472 feet from the West line (Lot 3) of Section 3. Accordingly, the **Neptune 10 State Com No. 503H** is approximately 8 feet closer to the eastern boundary than is currently authorized by NSL-7483.

EOG respectfully requests that pursuant to 19.15.15.13.C NMAC, the Division amend NSL-7483 to reflect the as-drilled location of the wellbore. The unorthodox location encroaches only on the spacing and proration unit to the East.

As support for this application, EOG provides the following additional information and exhibits:

Exhibit A is the amended Well Location and Acreage Dedication Plat (Form C-102), which shows, as drilled, the non-standard location for the **Neptune 10 State Com No. 503H**.

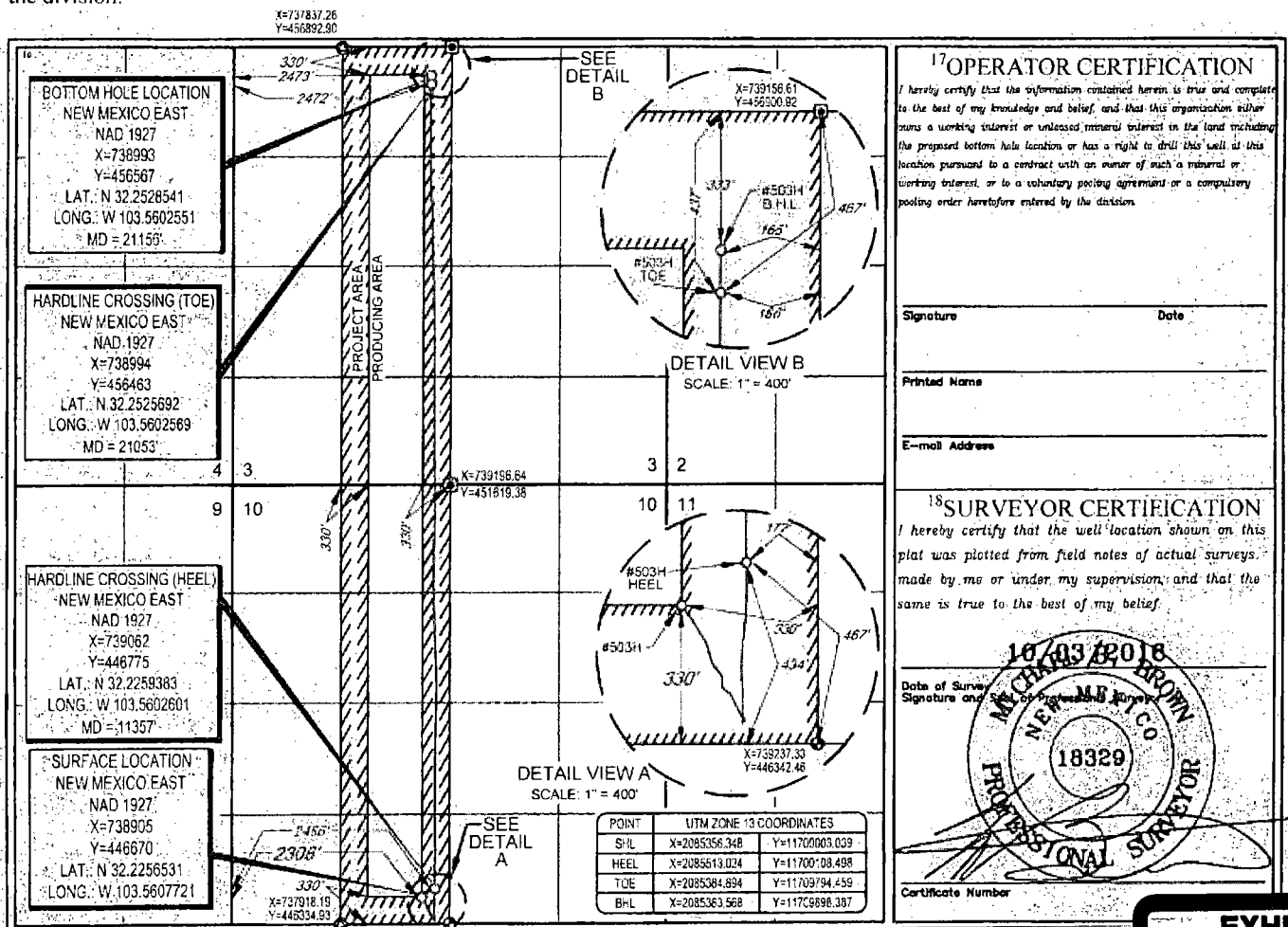

You have requested to drill this horizontal well at an unorthodox oil well location described above in the referenced pool or formation. This location is governed by statewide Rule 19.15.15.9.A NMAC, which provides for 40-acre units, with wells located at least 330 feet from a unit outer boundary. This location is unorthodox because portions of the proposed completed interval are closer to outside boundaries of the proposed project area than any location that would be a standard location under the applicable pool rules.
