Devon Energy Production Company, L.P. (OGRID 6137) is hereby authorized to surface commingle oil and gas production from the Paduca; Bone Spring (O) Pool (pool code 96641) located in Section 14, Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico;

The combined project area for these wells include the Entire Section 14, Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico.

The commingled gas production from the wells detailed above shall be measured and sold at the Cotton Draw 14 Federal Com. Well No. 1H Central Tank Battery (CTB), located in Unit D, Section 14, Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico.

Production from the subject wells shall be determined as follows:

The oil and gas production from each well shall be continuously metered before commingling.


The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2).

Subsequently drilled wells that produce from the subject pool within the project areas approved by this order may be added to this commingling authority by submittal of a Sundry Notice to the Engineering Bureau in Santa Fe.
