## ADMINISTRATIVE POOL/LEASE COMMINGLING ORDER

Administrative Order PLC-474 Administrative Application Reference No. pMAM1715032085

Pursuant to your application received on May 26, 2017, Occidental Permian LTD (OGRID 157984) is hereby authorized to surface commingle oil and gas production from the following pools:

Fowler; Upper Yeso (26680) Fowler; Drinkard (26220) Fowler; Ellenburger (26410)

and from wells, and their associated leases and pools identified in Attachment No. A and made part of this order. These wells are located on federal leases in Township 24 South Range 37 East, Lea County, New Mexico.

The commingled gas production from the wells detailed above shall be measured and sold at the South Mattix Unit Federal Battery central tank battery (CTB) in Unit G of Section 15, Township 24 South, Range 37 East, NMPM, Lea County, New Mexico.

Production from the subject wells shall be determined as follows:

Production for the separately owned leases shall be measured with a combination of well testing and metering. Each well shall be tested monthly for oil and gas production through a three-phase test separator. The remaining wells shall flow through a three-phase test separator. Each well shall be tested for a minimum of 24 hours.

The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

After initial notification, future wells that will produce from the pools and leases approved by this order may be added to this commingling authority by submittal of a Sundry Notice to the Engineering Bureau in Santa Fe.

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

For future additions of wells, leases, and pools to this commingling operation, notice shall only be given to those interest owners in the wells, leases or pools to be added, in accordance with Division Rule 19.15.12.10 C (4) (g) NMAC.

This approval is subject to like approval from Bureau of Land Management before commencing commingling operations.

The operator shall notify the Hobbs District office of the Division prior to implementation of the commingling operations.
