Mewbourne requests approval of an unorthodox location for the above well from a point beginning 975 feet FNL (15 feet from the south line of the well unit) of Section 6, to a point 660 feet FNL of Section 6 The reasons for this request are as follows.

- If the request is not granted, and the well cannot produce until the wellbore is 660 feet FNL of Section 6, the well will lose approximately 475 feet (10%) of productive wellbore, thus causing waste of reserves and making the well less economic
- 2. State Lease K-4097-1 covers Lots 1, 2, 7, and 8 of Section 6, and it has common ownership Federal Lease NM 037527(a) covers Lots 3-6 of Section 6, and it has common ownership

The well unit for the subject well is being communitized (the Land Office has approved the agreement, and Mewbourne is waiting for BLM approval) Mewbourne has a proposed well in Lots 5-8 of Section 6 The well unit for that well will also be communitized

The interest owners in the well unit comprising Lots 5-8 of Section 6 will not be adversely affected by the unorthodox location because of common ownership and communitized production

The proposed Roscoe 6 B3HE Fed Com Well No 1H is located in the southern portion of its well unit See Exhibit A The two wells nearest approach to each other is 1125 feet, and there will be no interference between wells
