Dear Mr. Seay:

Reference is made to your letter, received May 6, 2016, on behalf of MNA Enterprises LTD Co. providing notice of your intent to convert this disposal well from lease-only into a commercial disposal well. Your letter asks the Division to consider this action and provide feedback.

This well has been used to re-inject the water produced from surrounding producing wells completed also in the Delaware Mountain Group [Mason; Delaware, North Pool (44859)] and operated by MNA Enterprises LTD Co. It is surrounded on all sides by producers, some of which are still producing oil. Two of these wells seem to have watered out. The conversion to commercial disposal will have either a positive or negative effect on the remaining producing wells. It is our understanding that the BLM has not objected to this.


There are a few items that the Division asks:

- a. Supply the Division with recent verification of the total depth of this well. This should be by wireline or tubing tally witnessed by or approved by the Artesia district office inspectors. Any deepening of this open hole must be approved by the BLM and the Division and also approved by the Santa Fe office after submission of another form C-108.
- b. Provide a contact person for this operator to Denise Gallegos in the Santa Fe office.
- c. Supply the Division with copies of any logs the operator has in its files on this well.
- d. Begin henceforth reporting tubing pressures on the C-115 report for this well.
- e. Verify to the Artesia district inspectors by chart recorder or other approved device that this well always remains below the 821 psi tubing pressure limit.

I hope that this letter finds you well. Please find attached a copy of the May 6, 2016 correspondence of Mr. David Catanach regarding the above referenced matter.

In regard to Mr. Catanach's requests:

- a. MNA Enterprises LTD Co. (MNA), intends to conduct remedial work on the Russell Federal 35 #2 as soon as possible. At the time this remedial work is being completed, MNA will verify the total depth of the well by wireline or tubing tally and will notify the District 2 office to allow inspectors to witness.
- b. A copy of correspondence to Denise Gallegos is enclosed.
- c. A copy of the only log that MNA has for the Russell 35 No. 2 is enclosed.
- d. Please find the four most recent C-115s filed by MNA. Note that MNA is reporting tubing pressure on the C-115s for the Russell 35 No. 2 well. The tubing pressure is verified daily by the pumper on a pressure gauge attached to the tubing.
- e. Lastly, since MNA took over the Russell Federal 35 Lease, the No. 2 well has always been on a vacuum. As such a chart recorder was not ever put in place on the No. 2 to record tubing pressure. MNA will install a chart recorder and begin

verifying tubing pressures to the District 2 office.
