The commingled gas production from the wells detailed above shall be measured and sold at the Lake Shore 10 Federal Com. Well No. 3 central tank battery (CTB) located in Lot 9 (NE/4 SW/4 equivalent) of Irregular Section 10, Township 21 South, Range 26 East, NMPM, Eddy County, New Mexico.

Production from the subject wells shall be determined as follows:

The gas production from each of the wells shall be measured separately before commingling at the CTB.

Oil production shall be measured separately at the individual leases.


The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

After initial notification, future wells that will produce from the pools and leases approved by this order may be added to this commingling authority by submittal of a Sundry Notice to the Engineering Bureau in Santa Fe.

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

**This approval is subject to like approval from Bureau of Land Management before commencing commingling operations.**

The operator shall notify the Artesia District office of the Division prior to implementation of the commingling operations.
