STIPULATION AND AGREEMENT

This Stipulation and Agreement, entered into between the New Mexico Oil Conservation Division of the Energy, Minerals and Natural Resources Department of the State of New Mexico ("the Division") and GOLDEN OIL HOLDING CORPORATION, the subsidiary for New Mexico operations of Golden Oil Company, debtor in possession in Case No. 03-36974-H2-11 in the United State Bankruptcy Court for the Southern District of Texas, Houston Division (GOLDEN),

WITNESSETH:

Whereas:

- A. GOLDEN is the operator of the wells identified on Exhibit "A" attached hereto ("Inactive Wells").
- B. The Division and GOLDEN have entered into this agreement to resolve the inactive well issues.

Now, Therefore:

- 1. GOLDEN agrees and stipulates that each of the Inactive Wells has been inactive for a period of one year plus ninety (90) days, in the sense that (1) there has been no actual production of oil or gas therefrom during that period, and (2) there has been no injection of fluids into any such well pursuant to any Division-approved injection permit or order.
- 2. GOLDEN hereby agrees that it will cause each of the Inactive Wells (specifically described on Exhibits A) to be brought into compliance not later than December 31, 2004, by either (a) restoring such well to actual production, (b) causing same to be plugged and abandoned and the site thereof to be remediated in full compliance with Division Rule 202, or (c) causing same to be temporarily abandoned in compliance with Division Rule 203.
- 3. GOLDEN shall, beginning with the month of May 2004, cause a minimum of five (5) wells per month to be brought into compliance, including final plugging and abandonment of at least two (2) wells. If more than five wells are brought into compliance during any month, the wells in excess of the five required herein shall be credited to GOLDEN's obligation hereunder for succeeding months, provided that Golden is not then behind schedule in completing its four wells per month obligation. If more than one well is finally plugged and abandoned during any month, the wells in excess of the one required herein shall be credited to GOLDEN's plugging and abandonment obligation for succeeding months provided that Golden is not then behind schedule in completing its one well per month plugging obligation. In any event, all of

the Inactive Wells shall be brought into compliance by December 31, 2004. A well shall be considered to be in compliance when (a) all necessary work has been performed to bring the well into compliance; (b) all necessary reports have been filed with the appropriate district office of the Division and (c) in the case of a plugged well, GOLDEN has reported to the district office of the Division that the site is ready for final compliance inspection, or (d) in the case of a well restored to production, actual production has commenced.

4. Golden's Plan of Reorganization calls for assignment and transfer of operations to other parties of the wells on the 71 and 363 leases. If and when this transfer is effectuated, then the following plugging schedule shall be required in lieu of that set forth in Paragaph 3:

All inactive wells must be restored to compliance by December 31, 2004

- 5. GOLDEN further agrees (a) to report monthly to the Division's Aztec district office on the progress made toward bringing the Inactive Wells into compliance, (b) to furnish to the Division's Aztec district office copies of all Sundry Notices filed with the United States Bureau of Land Management (BLM) with respect to each of the Inactive Wells, and (c) to immediately notify the Division in writing of any event which prevents or delays its performance pursuant to Paragraph 3.
- 6. GOLDEN further agrees that if any well it operates becomes non-compliant with OCD Rule 201 during the term of this agreement, such well will be restored to compliance, either by restoration of production, approved temporary abandonment, or plugging, not later than December 31, 2004.
- 7. GOLDEN further agrees to (1) promptly file Change of Operator forms to transfer operation of the wells it currently operates from Chace Oil Company to GOLDEN, (2) forthwith file all C-115s (Operator's Monthly Reports) and continue to file such reports when due, and (3) furnish copies of all sundry notices reporting compliance actions under this agreement to the Division's Aztec District Office, attn: Charlie Perrin.

8. GOLDEN agrees that, in the event of non-compliance, the terms of this agreement may be enforced by civil penalty pursuant to the provisions of the New Mexico Oil and Gas Act (NMSA 1978, Sections 70-2-1 through 70-2-38, as amended).

This agreement is subject to Bankruptcy Court Approval pursuant to a motion under Fed. R. Bankr. P. 9019.
