Pursuant to Division Rule 19.15.15.11, COG Operating LLC (COG) respectfully requests administrative approval of a Non-standard Proration Unit and Non-standard Project Area for the Copperhead 31 Fee #20H well. The proposed acreage dedication is less than the Purple Sage; Wolfcamp (gas) pool rules requirement and one spacing unit in the project area contains less than 70% of the required 40 acres. Attached is Form C-102 showing the project and producing areas of this well. The wellbore, as well as first and last take points, fall within the standard location boundaries.

COG is seeking approval of the non-standard unit due to the change of Wolfcamp pool rules in this area. 


