

Describe Area Affected and Cleanup Action Taken.* All fluids remained inside the impervious lined containment. A vacuum truck was dispatched and recovered 94 bbl of produced water. An XTO EHS Coordinator who is competent in the operation, maintenance, and inspection of all on-site equipment and facilities visually inspected the containment and verified that there was no visual evidence of a liner breach. All free standing liquids were recovered from the containment and the containment and equipment were power washed.

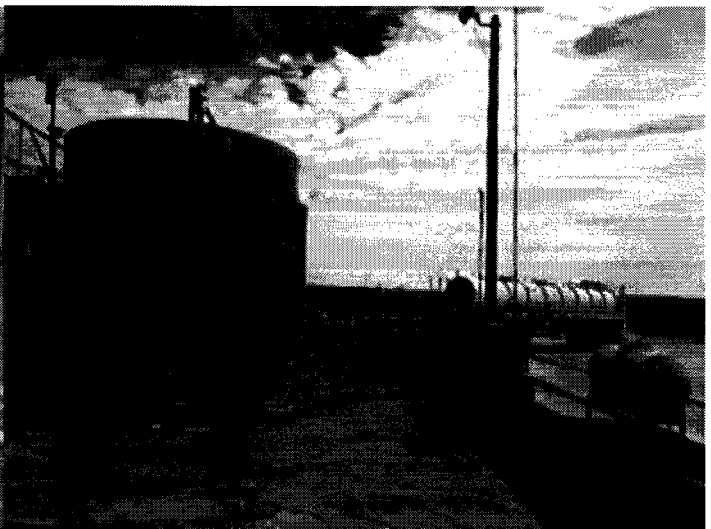
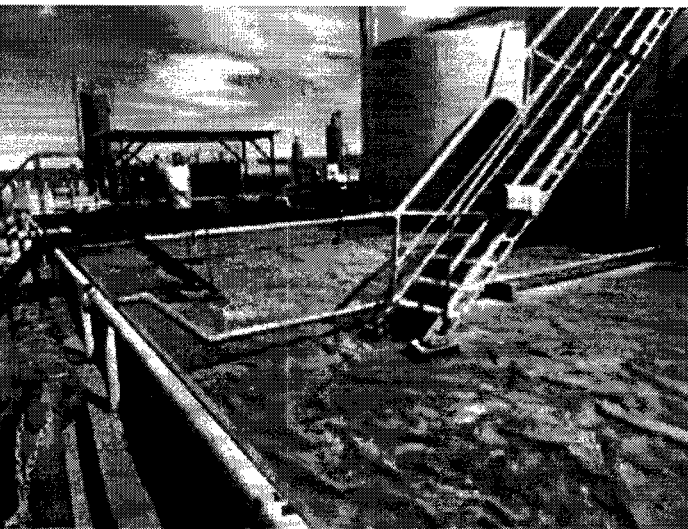
Location sign
