The cause is mechanical failure; nipple on a water transfer pump failed due to corrosion which resulted in spilling 30 bbls of produced water inside lined SPCC containment. All fluids were recovered. The containment liner was inspected immediately after the spill occurred. Based on the inspection, there is no evidence that the spilled fluids have left the containment.

Describe Area Affected and Cleanup Action Taken.*

The environment was not impacted by this spill. All fluids were contained inside lined SPCC containment.
