Hilcorp Energy Company is requesting administrative approval for a non-standard gas well location in the Basin Fruitland Coal Pool.

The Koch State Com 1A was originally drilled as a Blanco Mesaverde & a Blanco Pictured Cliffs in 1977. We are currently proposing to recomplete this well adding the Basin Fruitland Coal formation. This well will then be a MV/PC/FC commingled well.

The Mesaverde, Pictured Cliffs and Fruitland Coal pools at this location is considered NSL since the location is less than 660' from the boundary liner per Rule 104. Blanco Mesaverde and Blanco Pictured Cliffs was approved for non-standard location on 7/7/1977, administrative order NSL-863-0.

Production from the Blanco Mesaverde is included in the 320.00 acre gas spacing unit E/2 Section 36, T29N, R9W. Production from the Blanco Pictured Cliff is included in the 160.00 acre gas spacing unit E/2 Section 36, T29N, R9W. Production from the Basin Fruitland Coal is included in the 320.00 acre gas spacing unit S/2 Section 36, T29N, R9W.

To comply with the New Mexico Oil Conservation Division rules, we are submitting the following to help with your decision process:

1. 9 Section Plat showing wells in the area
2. Offset Operator plat for Section 36 T29N, R9W




Topographical Map






