You have requested an exception pursuant to Rule 19.15.16.15.3 NMAC, to approve a non-standard horizontal gas spacing unit comprising 200-acres, consisting of the entire area described above as the horizontal spacing unit. The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units which are being excluded. However, the affected party has signed a waiver, consenting to the non-standard horizontal spacing unit.

Applicant requested the non-standard horizontal spacing unit, to adequately develop the acreage, and to avoid placing a portion of the surrounding Poker Lake Unit into the proposed horizontal spacing unit.

Pursuant to the authority conferred by Division Rule 19.15.16.15.B.(5), the abovedescribed non-standard horizontal spacing unit is hereby approved. Further, the Applicant may add additional wells to the horizontal spacing unit with a Sundry notice to the Engineering Bureau.
