Pursuant to Order R-20253, LOGOS Operating, LLC received approval to operate the Section 30 Recycling Containment and Facility (#3RF-3) located in Section 30, Township 31N, Range 5W, Rio Arriba County, New Mexico through December 31, 2019. Approval of the extension was granted by Deputy Director Gabriel Wade on December 3, 2018. Conditions of Approval (COA) of the C-103 are listed below. This report is being submitted to satisfy the monthly report requirement.

#### 1.0 Conditions of Approval

Approval of the extension was granted with the following COA:

- Take necessary actions to keep fresh water accumulation within the containment to a minimum and prevent damage from freezing.
- 2) Inspect and take photographs of the Facility weekly.
- 3) In the event of leaks or damage to the Facility, the operator must do the following.
  - a. Notify OCD District III within 48 hours of knowledge of leaks or damage.
    - b. Submit a Corrective Action Plan (CAP) to repair leaks or damage within seven days of notification above.
    - c. Upon OCD's approval of the CAP, complete repairs per the OCD-approved schedule.
- 4) By the 15<sup>th</sup> of the month, submit monthly reports to OCD District III of inspection results with photographs and progress on CAP's if any.
- 5) Verify liner integrity before returning the containment to service.

#### 2.0 Weekly Inspections

LOGOS continues to monitor the condition of the Section 30 Recycling Containment. Attached is a summary of weekly inspections conducted at the containment from February 25 - March 24. Also attached is a photograph log documenting site conditions during February 25 - March 24.

#### 3.0 Recent Event Summary

- No new leaks have been discovered and previous repairs have held.
- LOGOS replaced the bad pump but is having difficulty getting it under the liner due to the pond being frozen. Working diligently to get pump under liner without damaging the liner.
- LOGOS personnel are continuing to search and inspect the liner for any potential areas of concern along the base of the containment and is gathering information for next steps forward for the containment.
- Per email received on 8/6/18 from Aztec OCD office the measured volume that was removed from the leak detection during each pumping event is attached.
